CURB STOP REPLACEMENT:

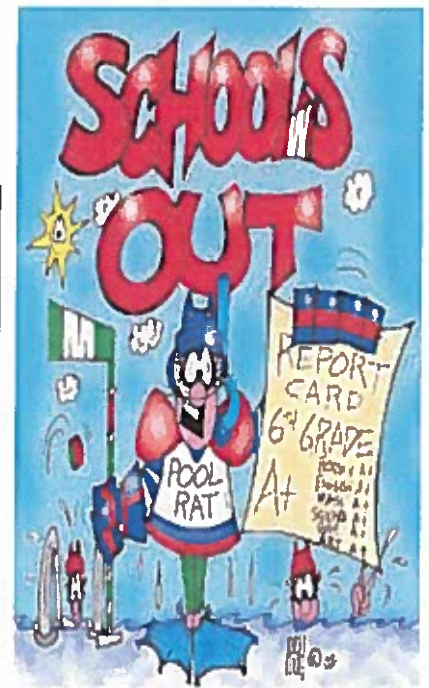

**VILLAGE OF WARNER
BYLAW NO. 566-17**

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE VILLAGE OF WARNER IN THE PROVINCE OF ALBERTA FOR THE 2017 TAXATION YEAR.

WHEREAS, the Village of Warner has prepared and adopted detailed estimates of the municipal revenue and expenditures as required for 2017, at the council meeting held on May 17th, 2017; and

WHEREAS, the estimated municipal expenditures and transfers set out in budget for the Village of Warner for the 2017 Budget total \$ 1,048,733; and

WHEREAS, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$ 623,832 and the balance of \$ 424,901 to be raised by general municipal taxation; and

WHEREAS, the requisitions are:

Alberta School Foundation Fund (ASFF)	
Residential/Farmland	\$ 46,360
Non-residential	\$ 15,283
Senior Foundation	\$ 9,269

WHEREAS, the Council of the Village of Warner is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

WHEREAS, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M26, Revised Statutes of Alberta, 2000; and

WHEREAS, the assessed value of all property in the Municipality of the Village of Warner as shown on the assessment roll is:

NOW THEREFORE under the authority of the Municipal Government Act, the Council of the Village of Warner, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Village of Warner:



2. The minimum amount payable for all properties as property tax for general municipal purposes shall be \$ 250.00
3. If, as of closing time of the Village Office on the 31st day of August, 2017, any taxes which remain unpaid shall receive a 12% penalty on the 1st day of September, 2017.
4. A 12% penalty will be imposed on the unpaid balance on the 1st day of January, 2018.
5. That this bylaw shall take effect on the date of the third and final reading.

Read a first time this 17th day of May 2017.
 Read a second time this 21st day of June 2017.
 Read a third time and passed this 21st day of June 2017.

The Council of the Municipal District of Taber invite you to attend a meeting with the M.D. of Taber and the Highway 3 Twinning Association to discuss the Highway 3 Twinning project.

With the completion of the recent cost / benefit analysis study it came as no surprise that there is a 3:1 return on investment in twinning of the highway.

The Municipal District of Taber supports the concept of twinning Highway 3. We consider this issue to be a priority for the following reasons:

- Increasing economic activity arising from the growth of specialized agriculture within the Municipal District of Taber has resulted in increased traffic volume
- This is the only east / west highway in the Province to not be twinned
- High incidence of use of the highway by wide / slow agricultural traffic

Although the response provided many reasons for recent decisions, we would like to again stress the importance of maintaining local registry agents within small and rural communities throughout Alberta.

Supporting and preserving local businesses in small communities is at the core of ensuring the vitality of rural Alberta communities. For this reason, we request a meeting with you to discuss the challenges and barriers that many Albertans living in small communities face when the internet is the sole method for provincial government interaction. Additionally, we'd like to discuss with you the need for ongoing economic development and investment in local industry and rural and small communities.
